1. **SCOPE OF WORK:**

The Town of Drumheller is requesting bids to replenish our gravel supply and require 5000 tonnes, of 20 mm Crushed Gravel delivered over a 3-year period for a total weight of 15,000 tonnes.

The Gravel supply will be weighed at the Drumheller Regional Landfill, delivered to the Town of Drumheller's Public Works yard located at 702 Premier Way, between regular office hours of 8:00 am & 4:30 pm, no after hour deliveries will be accepted.

Truck drivers will be required to sign in at the front desk prior to entering the yard.

Specification for

2020, 2021, 2022

Crushed Gravel Supply

Material:

Sound, hard, crushed pit gravel of uniform gradation having a face fracture of 60% on material retained on the 5mm sieve.

Gradation:

| Sieve Size | Percent Passing |
|------------|-----------------|
| 20 mm | 100 % |
| 12.5 mm | 70-95 % |
| 5 mm | 40- 60 % |
| .630 mm | 17-30 % |
| .160 mm | 7-15 % |
| .080 mm | 5 -10 % |

Testing:

The consultant will provide gradation testing twice a week while the material is being delivered. Control testing during crushing, blending or removing excess is the supplier's responsibility to have verified.

Weight:

All gravel supplied shall be weighed prior to placing in stockpile at Public Works located at 702 Premier Way. The Town of Drumheller will cover the cost of scaling during regular business hours.

The scale will be open within regular work hours: 8:00 a.m. – 4:30 p.m. Monday to Friday.

Stockpile:

The stockpile site is located at 702 Premier Way. The stockpile shall be built by covering the entire projected area then flattening it to receive a second lift. Dozer work to flatten the pile is to be included in the bid. Widening of the stockpile by means which may cause segregation will not be permitted.

Payment:

Payment will be made according to the weight on a monthly basis.

Schedule:

All material is to be delivered prior to March 15 of the calendar year.
