7.1 CHIEF ADMINSTRATIVE OFFICER

7.1.2 Request for Decision: Proposed Borrowing Bylaw for the Penitentiary Water Booster Station Upgrades

The existing Penitentiary booster station and transmission main were constructed in 1963. Due to its age and condition, the penitentiary booster station needs immediate upgrades to continue to provide reliable, continuous, and safe water supply and to support emergency fire service delivery to the Drumheller Penitentiary and the Churchill Co-op Reservoir, as well as the recreational users at the Stampede and Ag Society and DORVA.

The project was approved by Council in January 2022 as part of the Town's 2022 Capital Budget and is to be financed by issuing debentures.

The Town is in the process of contacting the Drumheller Penitentiary and Churchill Co-op (Kneehill County) to ask if there would be interest in contributing to this project.

There is a possibility to lower the borrowing and use more reserves. The Bylaw will not allow the Town to borrow more than what is stated, but less may be borrowed. A debt limit calculation was provided to Council.

There is capacity in the utility budget therefore there will be little impact.

Follow Up Items from the Discussion

Review the Debt Management Policy C-02-04 in the Fall. The Policy sets a limit to the amount of debt that can be held by the Town.

There will be a Reserve Policy brought to Council which will recommend minimum and target reserve levels.

Utility Rate Model is being created and will be brought back to Council for approval. The model will be used from 2023 to 2027

The Flood Mitigation Project started near the end of 2019 to design and build infrastructure to protect people and property in the Town of Drumheller. The project aims to build new berms and raise existing berms from 2020 to 2024. The \$5 million is the Town of Drumheller's 10% contribution for the project that is funded 50% by Alberta and 40% by Canada.

Administration recommends Council repeal Bylaw 05.17 and Bylaw 04.18, which were authorized to borrow for previously approved flood mitigation projects under ACRP grants approved in 2017; funds were not borrowed under these bylaws.

SUMMARY:

As part of the Town's Flood Mitigation Project and provincial funding agreement, the Province is transferring the ownership of several berms that currently sit on Public road rights-of-way. A portion of these rights-of-way need to be closed for the construction of the new berms. This Bylaw deals with closing a portion of the right of way along Riverside Avenue West in West Newcastle.

RECOMMENDATION:

That Council gives First Reading to Bylaw 11.22 West Newcastle Road Closure and sets the Public Hearing date for August 2, 2022.

DISCUSSION:

When the Province of Alberta constructed berms in Drumheller, the berms were largely built on their lands by way of road rights-of-way, especially if adjacent to an existing road. Under the funding agreement between the Town and Alberta Environment, the ownership of the berms is transferred to the Town and as such, the lands they sit on shall also be owned by the Town of Drumheller. This road closure bylaw will accomplish that task for the West Newcastle Berm.

There is a difference between a right of way and a road. A road is the surface that is contained within the right of way and is generally 7-9 meters wide. A right of way is a legal entity under the ownership of the Province and it varies from 6 meters (for an alley) to 20-40 meters for a street or avenue. Many rights of way, at least in Drumheller area, may not have a road contained within the boundary. In the case of rights of way adjacent to the Red Deer River, the right of way extends to the water's edge as shown in the attached drawings.

The closures in this Bylaw are outlined as thus:

- Parcels 'A' and 'B' This is surplus land from the closure that will be made available to the two property owners at fair market value. Parcel 'B' is smaller as they had previously acquired some of the right of way from the Town in 2018. Both properties have or had extended their fence line well into the right of way many years ago.
- Parcel 'C' This berm is currently an alley behind two homes. Both homes have front drives, and it appears the garbage truck is the main user of the alley. It is the intent to remove this alley surface when closing the right of way.
- Parcel 'D' There is no change to Riverside Avenue West as the right of way will be closed from the river edge to a line 2 meters from the existing retaining wall to allow for repairs of the wall in the future. There is no physical change to this roadway.

- Parcel 'E' This right of way is behind four properties on Riverside Avenue West. Closing this legally allows the town to prevent public access to the berm unlike now where it exists as a public road right of way.
- Parcel 'F' This is a right of way with drainage utilities located within the boundary including a gate structure for flood control.

The land where the berms are being placed or rights of way are being closed will be converted into Public Utility Lots to align with the other land in the valley that berms currently or will reside upon.

FINANCIAL IMPACT:

The costs to convert this land is included with the Flood Mitigation project and is a requirement of the provincial funding agreement.

STRATEGIC POLICY ALIGNMENT:

Flood Mitigation is the key strategic priority of this Council and Administration.



SUMMARY:

As part of the Town's Flood Mitigation Project and provincial funding agreement, the Province is transferring the ownership of several berms that currently sit on Public road rights-of-way. A portion of these rights-of-way need to be closed for the construction of the new berms. This Bylaw deals with closing a portion of the right of way along 10th Street West and 2nd Avenue West in East Newcastle. This Bylaw also deals with some 'housekeeping' of road rights of way that exist in Newcastle Park as shown on Schedule 2.

RECOMMENDATION:

That Council gives First Reading to Bylaw 12.22 East Newcastle Road Closure and sets the Public Hearing date for August 2, 2022.

DISCUSSION:

When the Province of Alberta constructed berms in Drumheller, the berms were largely built on their lands by way of road rights-of-way, especially if adjacent to an existing road. Under the funding agreement between the Town and Alberta Environment, the ownership of the berms is transferred to the Town and as such, the lands they sit on shall also be owned by the Town of Drumheller. This road closure bylaw will accomplish that task for the East Newcastle Berm.

There is a difference between a right of way and a road. A road is the surface that is contained within the right of way and is generally 7-9 meters wide. A right of way is a legal entity under the ownership of the Province and is varies from 6 meters (for an alley) to 20-40 meters for a street or avenue. Many rights of way, at least in Drumheller area, may not have a road contained within the boundary. In the case of rights of way adjacent to the Red Deer River, the right of way extends to the water's edge as shown in the attached drawings.

The closures in this Bylaw are outlined as thus:

- Parcels 'G' The existing and proposed berms are on the existing 10th St W right of way.
 The road actually extends on lots R-16 and R-17 (both Town owned) so closing a portion of this right of way will not affect the travelled road surface.
- Parcel 'H' and 'K' This portion of 2nd Avenue West has the existing and proposed berm bisecting the right of way. This road will be closed to vehicular traffic because of the height of the new berm. The remainder of 'K' will be closed to clean up the land parcels within the park.
- Parcel 'J' This is an alley right of way that contains utility services but no road and has a portion of the berm bisecting the right of way. There is no change to the water and sewer servicing from these pipes, nor change in access to this area.

Parcel 'L' – This right of way is being closed as housekeeping only. This large parcel
includes some utility lines and is a large natural area. There will be no changes to this
area once converted to a utility lot

FINANCIAL IMPACT:



SUMMARY:

As part of the Town's Flood Mitigation Project and provincial funding agreement, the Province is transferring the ownership of several berms that currently sit on Public road rights-of-way. A portion of these rights-of-way need to be closed for the construction of the new berms. This Bylaw deals with closing a portion of the right of way along North River Drive in Midland.

RECOMMENDATION:

That Council gives First Reading to Bylaw 13.22 Midland Road Closure and sets the Public Hearing date for August 2, 2022.

DISCUSSION:

When the Province of Alberta constructed berms in Drumheller, the berms were largely built on their lands by way of road rights-of-way, especially if adjacent to an existing road. Under the funding agreement between the Town and Alberta Environment, the ownership of the berms is transferred to the Town and as such, the lands they sit on shall also be owned by the Town of Drumheller. This road closure bylaw will accomplish that task for the Midland Berm.

There is a difference between a right of way and a road. A road is the surface that is contained within the right of way and is generally 7-9 meters wide. A right of way is a legal entity under the ownership of the Province and is varies from 6 meters (for an alley) to 20-40 meters for a street or avenue. Many rights of way, at least in Drumheller area, may not have a road contained within the boundary. In the case of rights of way adjacent to the Red Deer River, the right of way extends to the water's edge as shown in the attached drawings.

There is no change to North River Drive, nor 25th St NW, other than the road right-of-way on paper will be reduced to south and west edges of the pavement, respectfully. There is no physical change to the roadways in this area.

The land where the berm is being placed will be converted into Public Utility Lot to align with the other land in the valley that berms currently or will reside upon.

FINANCIAL IMPACT:

The costs to convert this land is included with the Flood Mitigation project and is a requirement of the provincial funding agreement.

STRATEGIC POLICY ALIGNMENT:

Flood Mitigation is the key strategic priority of this Council and Administration.

Midland Road Closure

THIS IS A BYLAW of the TOWN OF DRUMHELLER, in the Province of Alberta for the purpose of closing portions of underdeveloped Streets as depicted on:

SCHEDULE – 3 AREAS – 'A', 'B' and 'C'

being part of "Street" created by Plan 7291 C.G. (now North River Drive) and "25th Street" created by Plan 811 0811 and all of "Street" created by Plan 811 0811, and

SCHEDULE - 4 AREA - 'D'

being part of "Street" created by Plan 7291 C.G. (now North River Drive) all within the W.1/2 Section 9 and the S.E.1/4 Section 9 in Township 29, Range 20, W.4th Meridian, and

SCHEDULE - 5 AREA - 'E'

being part of "River Drive" created by Plan 1561 J.K. (now North River Drive) and part of the "Original Road Allowance" between the S.E.1/4 Section 9 and the S.W.1/4 Section 10, to public travel and acquiring title to these lands in the name of the TOWN OF DRUMHELLER pursuant to Sections 22 and 23 of the Municipal Government Act, Chapter M-26, Revised Statues of Alberta 2000, as amended.

WHEREAS; the Town of Drumheller, the Province of Alberta and the Government of Canada have entered into an agreement to construct flood mitigation dikes along portions of the Red Deer River in the Town of Drumheller to protect properties and the citizens of Drumheller from the ravages of flood waters, and

WHEREAS; it has been found that construction of flood mitigation dikes in the subject areas is impossible without encroaching upon and using parts of the adjacent public streets, and

WHEREAS; the existing dikes already occupy portions of undeveloped streets and the proposed new dikes and enhancement thereto will continue to occupy portions of undeveloped streets, and

WHEREAS; the parties hereto have agreed that land used for dike construction must be in the name of the Town of Drumheller, and

WHEREAS; the Council of the Town of Drumheller is satisfied that this activity is in the best public interest, and no one will be adversely affected by this road closure Bylaw; and

WHEREAS; a notice of these Road closures was published in the Drumheller Mail once a week for two consecutive weeks; on and again on the last of such publications being at least five days before the day fixed for the passing of this Bylaw; and

WHEREAS; the Council of the Town of Drumheller held a public hearing on the day of , 2022 at their regular or special meeting of Council in which all interested parties were provided an opportunity to be heard;

NOW THEREFORE; be it resolved that the COUNCIL of the TOWN OF DRUMHELLER, in the Province of Alberta does hereby enact to close those portions of the undeveloped Streets shown depicted on the attached Schedules - 3, 4 and 5 which are more particularly describe as:

PLAN AREAS – 'A', 'B', 'C', 'D', and 'E' EXCEPTING THEREOUT ALL MINES AND MINERALS

to public travel and acquiring titles to these lands in the name of the TOWN OF DRUMHELLER with a mailing address of; 224 Centre Street, DRUMHELLER, Alberta T0J 0Y4 pursuant to Sections 22 and 23 of the Municipal Government Act, Chapter M-26, Revised Statues of Alberta 2000, as amended.







TITLE:	Building Community Resilience by Ending Working Poverty Project (EWP)

SUMMARY:

EWP will bring together a cohort of five Communities Ending Poverty members from across Canada. Through coaching, capacity building, creating opportunities, and prototyping strategies, the cohort will test whole community approaches with the goal of achieving a 5% reduction in working poverty in each community.

Drumheller's application to participate in this project has been approved by Tamarack. This secures Coordination funds of \$20,000 per year for three (3) years from Tamarack, which must be at least matched by the applicant.

RECOMMENDATION:

Administration recommends a funding allocation of \$30,750 per year for three (3) years to partially fund a temporary Ending Working Poverty Project Coordinator for 4 days per week (0.8 FTE) plus related costs (provision of a cell phone, training) totaling approximately \$5,000.

Administration further recommends the provision of in-kind support such as IT equipment and Communications team support to the project, as required.

DISCUSSION:

At 42%, the working poor make up the single largest group of people in Canada living in poverty – 1.6 million people (StatsCan). Working poverty is a significant problem in the Drumheller Valley. 15% of households accessing the food bank in the first quarter of 2022 were working either full or part time. According to Stats Can, the unemployment rate in Drumheller in 2021 ranged from 10% in January to 6.5% in June, rising to 8.8% in December. This is indicative of the seasonality of employment (and thereby underemployment and unemployment) in the Valley. The Living Wage is \$19.70/hour but the average starting salary for vacant positions last quarter was \$16/hour, highlighting a significant affordability gap for workers. This gap is underlined by 22% of households that are spending 30% or more of their income on shelter costs and the 12.9% of children aged 0-5 years living in low-income households (Stats Can, 2016).

Working poverty and seasonal employment also impacts business. A recent survey found that 67% of businesses expect to hire in the next 12 months and 92% of them think they will face challenges in hiring. 35% or employers rate the available labour force as 'poor'. Despite this, 48.5% plan to expand in the next 2 years. This project provides an opportunity to target resources at a tangible goal with the support of experts and in collaboration with 4 other communities across the country. Reducing working poverty will ultimately improve the lives of our residents and ensure that businesses have the qualified workforce that they need.

As part of the local EWP Initiative, with support from Tamarack Managers of Cities (MoCs), coaches, and consultants, Drumheller commits to these ten collaborative goals:

- 1. Driving toward at least a 5% reduction in working poverty in the community.
- 2. Collecting working poverty data, improving local data access, and publishing a local working poverty profile.
- 3. With the cohort, co-developing a shared theory of change and measurement framework for the project.
- 4. Actively participating in a cohort Community of Practice and in a national collaborative.
- 5. Developing, implementing, and reporting on an annual local workplan and budget.
- 6. Developing and prototyping local strategies, projects and initiatives that reduce working poverty (e.g., that improve training, employment, financial well-being, and bankability).
- 7. Continually building out local networks, partnerships, and capacity.
- 8. Committing to engaging people with lived/living experience as leaders.
- 9. Contributing to Communities Ending Poverty learning (e.g., events, case studies, webinars & blogs).
- 10. Contributing to annual learning reports and a national toolkit that will share challenges and successes, and that will support this work to be scaled to additional communities.

Grant commitments

The successful grant application noted that funding would be allocated to:

- Hiring an Ending Working Poverty Project Coordinator.
- Tamarack advised that a commitment of at least 0.66 FTE would be required to undertake this project. Administration anticipates that 0.8 FTE is more realistic. Based on the current salary model and anticipated related position costs, the total per year for 4 days (0.8FTE) is \$52,400.
- A Barrier Reduction Fund to support project participation and leadership by people with lived/living experience. This might include pay, honoraria, gas cards, childcare, training etc.

People with lived/living experience deeply understand the realities of poverty. Their stories and experiences serve as powerful tools for building compassion, and for disrupting and clarifying a community's understanding of its root causes and scope. The invaluable expertise of these individuals adds strength and resiliency to poverty-reduction work, and their first-hand knowledge of systemic barriers is invaluable in co-creating innovative solutions to overcome them. This fund will ensure that barriers to participation are reduced and that the time of participants with lived/living experience is valued.

• Supporting capacity building opportunities as needed for those with lived/living experience.

To facilitate participation and leadership and to improve opportunities for participants to move/remain out of poverty.

To date seven (7) representatives from the community, non-profit and business sectors have committed to the Leadership Team for this project, in addition to the 2 representatives from the Town of Drumheller/Drumheller Valley FCSS.

FINANCIAL IMPACT:

Funding this project will require an additional budget allocation to Poverty Reduction for three (3) years as outlined below:

Spring Emergency Management Readiness - Completed

In cooperation with the flood mitigation team we are working on a new addendum to include the flood mitigation work into the existing plans and have engaged a contractor well versed in the field to assist. This is a multi year undertaking to carry it through. We had a tabletop emergency exercise on March 25 in the ECC simulating a flood and additional jeopardies for staff to work through using the Incident Command System. Staff have taken part in emergency readiness webinars with the province in past weeks as well.

In response to the anticipated low pressure weather event of the week of June 12 public works crews readied our flood mitigation equipment, sandbags were made for public dispersal and the CAO's office, communications and emergency and protective services were working closely together and in regular communication with our AEMA officer and the Dickson dam staff.

Remedial Properties Policy - Completed

This was reviewed by Council and passed in January. This will be communicated to citizens to all are aware of the emphasis placed on clean and tidy properties throughout the valley.

New Traffic Bylaw – For first reading July 18

Municipal enforcement staff are continuing work on this draft and shall bring it to council in July.

Mutual Aid Agreements – Emergency and Fire Services – Incomplete but on schedule

The director has been in discussion with a contractor to complete this review and production of new agreements with our partners.

Fire Chief Position – Replacement process underway

The director and HR manager have worked closely together to compile a job description and the ad for the position is now posted publicly. We have inquiries from several parts of the country and are dedicated to the process to identify a suitable replacement to become our first full-time fire chief.

Land Purchase

- Floodway Buyout Program:
 - All properties identified for buyouts in Central Rosedale, West Rosedale, and Nacmine have been purchased (10 total); house relocation and/or demolition is underway
 - Lehigh buyouts four properties purchased to date in 2022, in addition to two purchased in past years, eleven remaining. House removals/demolitions will begin in July.

Design

- Preliminary design of all funded projects has been underway over the past several months, with selected projects scheduled for 2022 construction moving to detailed design and tender preparation in April, May and June.
- Following June 6, 2022 Council update and decision, optimization of four berm projects has been completed (Midland, Newcastle, North Drumheller Grove Place and Willow Estates) and tender packages prepared.
- Optimization of remaining berm projects will proceed through the late summer and fall.

Tenders

- Downtown Dike Phase 1 was tendered in April 2022. Council decided on May 9, 2022. to cancel this tender as pricing came in over the allocated budget to cancel the tender and optimize the design.
- Tenders for four berm projects (Midland, Newcastle, North Drumheller Grove Place and Willow Estates) were posted June 20 and 21 and will close on July 12. The tenders will be brought to Council for approval on August 2.



Grants & Budget

- Based on the Downtown Dike tender pricing construction cost escalation has pushed the Flood Mitigation Program's budget above the current available budget
- Additional Grant funding has been requested from the Federal Disaster Mitigation and Adaptation Fund during their November 2021 intake. The Mayor and CAO have lobbied the Provincial Government for additional funding in May 2022.
- Council has directed the Food Mitigation Office to optimize on berm designs to allow for as many berms as possible to be constructed under the available funding. This work is underway and the upcoming four tenders will also provide additional certainty on construction costs.

LUB/MDP/DARP

Updates to the Provincial Flood Hazard mapping are underway. The Town expects to receive a draft copy for review in the coming weeks. The LUB will be linked to these updated flood hazard maps, once finalized.
