To All Bidders:

1. General

- 1.1. This addendum shall be read in conjunction with the Specifications prepared for the Request for Tender – DRFM-2023-01-20 (Pre-Construction Tree Clearing).

1. A – Downtown Dike Work Zone

Please see attached updated Project Drawings, Schedule of Prices - PDF, and Schedule of Prices – Spreadsheet that include an additional Schedule E (Downtown Dike). The additional tree removal and brush clearing within Schedule E will follow the same specifications, including measurement and payment, as the existing Schedules.

Section 3.3.1 has been updated to include Item No. “5.1, 5.2, and 5.3” under Item Name “Tree and Brush Removal” and Item No. “5.4” under Item Name “Brush Clearing”.

2. B – Questions

The following questions have been received by the Town.

Question 1: For smaller companies that only have a Small Employer Certificate of Recognition (SECOR), is that acceptable to the Town as an equivalent of a Certificate of Recognition (COR)?

Answer 1: Yes, for companies that have a valid SECOR through an approved Government of Alberta Certifying Partner, the SECOR would be acceptable as an equivalent of a COR.

Question 2: Can a contractor submit a 10 percent certified cheque with their bid package and then, if the successful bidder, an additional certified cheque for the surety?

Answer 2: Yes, this is acceptable for the Town. A tender deposit is required as part of the submission.

Question 3: Will the successful contractor need to have a certified arborist involved?

Answer 3: As part of the Work Plan submittal, there is the expectation that a certified arborist will be consulted to confirm the Work Plan around black knot fungus and Dutch elm disease.

Work in the field to confirm the presence of black knot fungus, Dutch elm disease, or other tree diseases should also involve a certified arborist.

3. C – Insurance Note

It has been brought to the attention of the Town, that depending on tree height, different insurance coverage is required. The Proof of Insurance will need to show that the contractor is covered for all trees that need to be remove, including, but not limited to, the different tree heights noted in the Project Drawings.
