	To better clarify the scope of this project, please see the following:
	Question: Do you know what engine is attached to the BBC Generator at the Water Plant?
	Answer: Serial Number: 12VF000905, Model: 61237300 Detroit Diesel 92.
	Question: <b>W</b> e would like to know the Engine Make/Model & Serial numbers for each generator, as the generator plates shown in the pictures do not provide that. Also, any oil/fuel filters number you have.
	Answer: Pictures have been attached.
	Question: Can you please provide addresses or GPS coordinates for each location?
	Answer: Drawings for each location have been added as an attachment to this Addendum.
	Question: The tags provided for "Water Plant" and "North Drumheller Lift Station" are alternator tags. Can you please provide generator data tags for these two units similar to the rest of the locations?
	Answer: The tag provided for the Water Plant was a generator tag. A new picture for the North Drumheller Lift Station has been attached.
	Question: Can you please let us know if there are any locations where the amount of cable exceeds 50 feet or need special attention for load bank testing?
	Answer: Water Treatment Plant
	Question: Are there breakers on the generators for load bank testing?
	Answer: It will be up to the successful proponent to determine if there are breakers on each generator. The Town will be open to discussing additional costs as such with the successful proponent.



Question: For automatic transfer switch (ATS) maintenance, we must isolate the transfer switch. Should there not be an option to bypass the ATS would it be acceptable to have a power outage to safely isolate the ATS during regular business hours?

Answer: It would be acceptable to have a power outage to safely isolate the ATS during regular business hours. It is up to the successful proponent to provide 48 hr notice to the Town when this work will commence.

Question: All life safety generator in Alberta are maintained as per CSA C282-15 which includes weekly, monthly, semi-annual, annual inspection and quinquennial (5 year) service. Do you want us to follow the scope of work indicated in CSA C282-15 which covers most of the listed scope of work in RFP and more.

Answer: Proponents shall follow the CSA C282-15. As per section 2.1 Scope of Work the list provided was not an extensive list of services.

Question: Do you require quinquennial (5 year) service pricing as per CSA C282-15 at this stage? If yes, we will require engine information (model & serial number)

Answer: In order to cover the quinquennial (5-year service) the Town will be adjusting its Cost Proposal Submission from 3 years to 5. Proponents shall include the quinquennial (5-year service).

Question: Is it possible to have an extension?

Answer: An extension will be provided.

The new closing date will be March 30, 2023 at 2:00 pm local time.

The Town will also extend its question period until March 21, 2023 at 2:00 pm local time.
